# 1. Safety Instructions

## 1.1 Explanation of the symbols



This product **must not** be disposed of with household waste!

## 1.2 Safety Warnings

If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or a similarly qualified person in order to avoid a hazard.

This appliance is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities or lack of experience and knowledge, unless they have been given supervision or instruction concerning use of the appliance by a person responsible for their safety. 



The vacuum is specifically designed to remove warm (<60°C) or cold (not burning) ash.

⊘	Do not vacuum any sharp-edged, hot or incandescent materials.	
⊘	The appliance should not be exposed to heat.	
⊘	Do not vacuum any moist or liquid substances. Never immerse the appliance in water.	
⊘	Unplug the appliance from the mains supply socket after use and before every cleaning. Pull the plug, not the mains cable, in order to disconnect the appliance from the mains.	
⊘	Do not put any object into openings. Do not use with any opening blocked. Keep free of dust, lint, hair etc.	
⊘	Do not use the vacuum cleaner without dust container or dust filter bag in place.	
⊘	Do not vacuum any flour, cement etc., in order to avoid the overloads.	
⊘	The appliance should only be cleaned with a dry or damp cloth; it should never be immersed into water. Do not use any solvents for cleaning.	
⊘	This appliance is intended for domestic use only and not for commercial applications.	
⊘	Avoid the nozzle or brush touching the surface of the furniture.	
⊘	Do not use the mains wire to carry the appliance. Do not pull the mains wire over sharp edges.	







## 3. Assembly



<p><b>HEPA Filter:</b> Inspect the HEPA filter in the dust container.</p>	 <p>V type nut</p>
<p><b>Dust container:</b> Attach the dust container to the hand vacuum cleaner.</p>	
<p><b>Flexible hose:</b> To use the flexible hose, insert the end of the hose into the suction hole. Make sure, that it is snapped in the position.</p>	
<p><b>Accessories:</b> Choose your desired accessory and attach it to the suction hole.</p>	

## 4. Operation

	Before you start the appliance, make sure that the dust filter is in the position.
	Unwind the power cord.
	Plug the appliance and switch on.
	Unplug the appliance after use.

## 5. Cleaning and Maintenance

 <p>V type nut</p>	Open the dust container.
 <p>Metal rod Dust filter Cover</p>	Take out the HEPA filter.
	Empty the dust container.
	Wash off the HEPA filter with water.

	<p>Dry up the HEPA filter.</p>
	<p>Assemble the vacuum cleaner.</p>

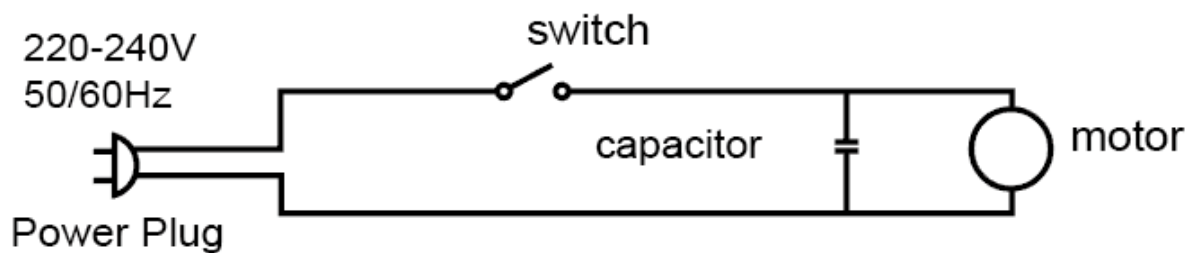
## 6. Error Detection

Before you contact our service center, please check the following:

Problem	Possible reason	Advice
<p>Motor does not start</p>	<p>-Power cord not firmly plugged into outlet -Outlet damaged -Cleaner not switched on</p>	<p>-Plug unit firmly -Check the Outlet -Switch on the appliance</p>
<p>Suction power is weaker</p>	<p>-Unit clogged -HEPA filter needs cleaning -Dust container not in position -Filter blocked</p>	<p>-Remove the blockage -Clean the dust filter -Attach the dust container again to the cleaner -Clean the filter</p>
